ARTICLES OF INCORPORATION

of

SOUND-SEA VILLAGE HOMEOWNERS ASSOCIATION, INC. A Non-Profit Corporation

I, the undersigned, a natural person of the age of eighteen years or more, do hereby make and acknowledge these Articles of Incorporation for the purpose of forming a non-profit corporation under and by virtue of the Laws of the State of North Carolina, as is contained in Chapter 55-A of the General Statutes of North Carolina, entitled "Non-Profit that end do hereby set forth:

ARTICLE I

The name of the corporation is SOUND-SEA VILLAGE HOMEOWNERS ASSOCIATION, INC., (hereinafter called the "Association").

ARTICLE II

The period of the duration of the corporation shall be perpetual.

ARTICLE III

The purposes for which the corporation is organized are:

- (a) To own, manage, maintain, operate and repair the roads, easements, entrance right of way, common properties, and other amenities of the subdivision known as Sound-Sea Village, and to that end:
 - To make and collect assessments against members to defray the cost of maintenance, operation and repairs of the roads, entrances, ways and common properties of the association.
 - To use the proceeds of the assessment in the exercise of its powers and duties.
 - To construct improvements on the common areas and to assess the membership.
 - 4. To make and amend reasonable regulations respecting the use of property within the subdivision and to enforce the restrictive covenants of the subdivision.
- (b) To perform and to do any and all other acts permitted by the Non-Profit Corporation Act of the North Carolina General Statutes, Chapter 55-A, necessary or desirable for the conduct and continuation of the management, operation and development of the subdivision.

ARTICLE IV

The members of this non-profit cororation consist of all record owners of lots within the subdivision. A person, firm, corporation or any entity capable of holding title to real estate in North Carolina automatically becomes a member of the corporation upon a deed of conveyance conveying one of the lots

in the subdivision to such person, firm, corporation or entity in the Register of Deeds office of Dare County; or upon the probate of a will of a deceased owner, the devisee named therein becomes a member; or upon the death of an owner intestate, his heirs at law automatically become members. Membership is terminated upon a conveyance of the lot in the sudivision or upon deathor upon the lot being transferred out of said member in any manner, whether by voluntary conveyance, a foreclosure under the terms of a deed of trust or mortgage, for taxes, or by execution against the lot to satisfy any lien or judgment.

ARTICLE V

The directors of the Association shall be elected in the following manner:

Directors shall be elected by members of the corporation at its regular annual meeting provided in the By-laws.
